# 7. Investment Consultant Report, New Century Partners - Steven Callow

Mr. Callow distributed the portfolio appraisal as of November 30, 2013. He reviewed the economic market report and noted an upward motion in the stock market. Because of this, he made some adjustments in the mutual fund portfolio. He sold DFA and Vanguard, and purchased Brown Management and Vanguard Selected Value.

The total market value as of November 30, 2013 was \$310,300,097. This breaks down as follows: \$503,568 in Common Stock; \$194,100,486 in Mutual Funds; \$9,585,877 in Real Estate Secured Notes & Bonds; \$18,547,039 in Real Estate Loans; \$7,705,025 in Real Estate Partnerships; \$13,062,824 in Venture Capital \$60,858,792 in Private Equity; and, \$5,936,485 in Cash & Equivalents.

# 8. Investment Management Report, WhiteStar Advisors - James Bishop

Mr. Bishop distributed the 2013 Third Quarter Report. He reviewed the real estate investments and holdings, cash distributions, principal and interest payment amounts, and the market value of the real estate equity. The total estimated market value of the Fund's real estate investments as of September 30, 2013 was \$37,350,443.

The Summary was reviewed in detail and Mr. Bishop responded to questions by the Trustees. The Report is attached to these Minutes.

# 9. Actuary/Consultant Report; Kaufmann & Goble - Sid Kaufmann and Marci Vukson

# A. Review of Actuarial Valuation

Mr. Kaufmann distributed and reviewed the Actuarial Valuation report as of September 30, 2013.

There was a lengthy discussion about what the Actuarial Valuation reflects. It was reported that it is likely the Fund will be in the green zone by January 1, 2014.

# 10. Administrator's Report, United Administrative Services - Donna Rios

# A. Retirement Count Report

Ms. Rios reviewed the Retirement Count Report for 2013, which indicated there have been a total of 22 Retirements and 3 Disabilities year-to-date. Retirement and Disability Counts for 2012 and 2011 were also reviewed.

# B. Retirement Report

The Trustees reviewed the New Retiree List dated December 10, 2013, which included seven retirees. It was M/S/C to approve the list as presented. The Retirement List is attached to these Minutes.
