#### 3. Minutes of June 10, 2014

The Trustees reviewed the June 10, 2014 Minutes. It was suggested that Item 13 be revised to change "deferred" to "reallocated." It was M/S/C to approve the Minutes with this revision

#### 4. Communications

#### 5. Delinquency Report - Mike Swanson

Chairman Swanson distributed the Delinquency Report dated September 18, 2014. The report indicates there are several contractors delinquent for the July 2014 fringe benefits payment due by August 20, 2014.

# 6. <u>Investment Consultant Report, New Century Partners – Steven Callow</u>

Mr. Callow distributed the portfolio appraisal as of August 31, 2014. He reported the total market value as of August 31, 2014 was \$332,005,519. This breaks down as follows: \$474,513 in Common Stock; \$216,806,222 in Mutual Funds; \$10,614,124 in Real Estate Secured Notes & Bonds; \$17,477,456 in Real Estate Loans; \$5,941,559 in Real Estate Partnerships; \$10,267,102 in Venture Capital; \$64,091,344 in Private Equity; and \$6,333,199 in Cash & Equivalents.

## 7. Investment Management Report, WhiteStar Advisors - James Bishop

Mr. Bishop distributed and summarized the 2014 Second Quarter Report. He reviewed the real estate investments and holdings, cash distributions, principal and interest payment amounts, and the market value of the real estate equity. The total estimated market value of the Fund's real estate investments as of June 30, 2014 was \$35,160,622. Mr. Bishop responded to questions of the Trustees concerning the real estate investments.

# 8. Actuary/Consultant Report; Kaufmann & Goble – Sid Kaufmann and Marci Vukson

## A. Review of Actuarial Valuation

Mr. Kaufmann distributed and reviewed the Annual Certification of the Multiemployer Plan Funding Status report for the plan year 2014.

## 9. Report by Counsel - Dick Grosboll

## A. <u>Update on Restated Summary Plan Description</u>

Mr. Grosboll distributed another draft of the Summary Plan Description/Plan document for the Defined Benefit Plan. He requested comments and any suggested changes as the goal is to publish and distribute the new SPD/Plan document within a couple of months. He reminded the Trustees that the Plan document, which is included as part of the SPD, will be re-filed with the IRS by January 31, 2015.

### B. <u>Annual Notice to Retirees – Summary of Suspension of Retirement Benefits</u>

Mr. Grosboll referenced the revised notice to retirees regarding suspension of retirement benefits. He reminded the Trustees that the Trustees had agreed with his recommendation that an annual Benefit Suspension Notice be sent to retirees each year. He distributed a revised notice to the Chair and requested any input. The Notice can be included with other mailings.

## 10. Administrator Report, United Administrative Services – Judy Sargent

#### A. Retirement Report

The Trustees reviewed the New Retiree List dated September 18, 2014, which includes seven retirees. It was **M/S/C** to approve the list with a correction to change "Dan Thomas" to "Dan Thompson." The Retirement List is attached to these Minutes.

Ms. Sargent referenced the Pre-Retirement Deaths report, dated September 18, 2014, which indicated there were no pre-retirement deaths during the report period.

#### B. Retiree Count Report

Ms. Sargent reviewed the Retirement Count Report for 2014, which indicated there have been a total of 20 Retirements and 1 Disability year-to-date. Retirement and Disability Counts for 2013, 2012 and 2011 were also reviewed.

### 11. Assets and Expenses

#### A. Financial Statements

Following review of the financial statements for April, May and June 2014, it was **M/S/C** to accept the financial statements as presented.

Mr. Saunders inquired about the line item "Transfer to Part A Benefit Checking." Ms. Sargent will send an email to Trustees with clarification.

#### B. Payment of Bills

The total costs will be split evenly between the Pension and Health & Welfare Funds.
