# A. NCCMP Annual Conference Save the Date

Ms. Sukovez referenced correspondence announcing the NCCMP Annual Conference dates October 8-10, 2012. It was noted that no Trustees would attend the conference.

#### 5. <u>Delinquency Report</u>

Trustee Swanson distributed the Delinquency Report as of March 14, 2012 relating to several delinquent contractors for the payment of January fringe benefits due by February 20, 2012. He noted there are four (4) contractors 30 days or more past due and he continues to work

closely with them to ensure payment. Further, he reported on the three contractors turned over to the collections attorney.

#### 6. Attorney Report (Dick Grosboll)

## A. <u>Update on DOL Fee Disclosure Requirements</u>

Mr. Grosboll distributed his memorandum dated March 14, 2012 and provided an overview of the final regulations under Section 408(b)(2) of the Employee Retirement Income Security Act of 1974 (ERISA) relating to requiring fee disclosures by pension plan service providers and fiduciaries managing plan assets. The final regulations are effective on July 1, 2012, and will apply to arrangements entered into after that date as well as to arrangements already in effect. Mr. Grosboll will work with the Administrators, Consultants and Auditor and will report back on the progress of developing the disclosure notices at the next meeting.

Legal Counsel also discussed the fee disclosure to participant rules.

# 7. <u>Investment Consultant Report, New Century Partners (Steven Callow)</u>

Mr. Callow distributed the New Century Partners' Participant-Directed Defined Contribution Plan Quarterly Presentation of Investments and noted he does not anticipate making any changes until June or July. As of February 29, 2012, the Total Cost of the Portfolio was \$37,476,675 and the Market Value was \$41,560,821. The Plan's investments consistently outperform the benchmarks.

The New Century Partners Quarterly Presentation of Investments dated March 14, 2012 is on file with the Administrative Office.
