#### D. <u>IRS Maximum Limits and Benefits</u>

Mr. Grosboll distributed a memo that outlined the changes announced by the IRS to the Pension and IRA contribution and benefit level limitations for the upcoming year. Additionally, the memo included information on the level of Social Security benefits and related matters.

#### E. <u>IRS Mileage Reimbursement Rate</u>

Counsel noted that the IRS had just released the mileage reimbursement rate for 2014, with a half-cent decrease from 56.5 cents a mile to 56 cents.

## 7. Investment Consultant Report, New Century Partners - Steven Callow

Mr. Callow distributed portfolio appraisals as of November 30, 2013. He reported no changes were made to the fund and that the market value has increased since the previous report.

The total market value of the portfolio as of November 30, 2013 was \$51,622,668, with \$31,932,434 in Mutual Funds, \$19,689,402 in Unit Trusts, and \$832 in Cash & Equivalents.
