#### 1. Call to Order

#### 3. Minutes

#### A. March 12, 2013

The Trustees reviewed the Minutes. Following review, it was **M/S/C** to approve the Minutes of March 12, 2013 as presented.

#### 4. Correspondence

#### A. Fund Fee Recoveries

The Fund received a check from Kaufmann and Goble in the amount of \$12,205.26 for Fund Fee Recoveries which exceeded their fee for the fourth quarter of 2012. Also, a check in the amount of \$12,204.80 was received for the first quarter of 2013.

#### 5. <u>Delinquency Report – Mike Swanson</u>

Chairman Swanson distributed the Delinquency Report as of June 11, 2013 relating to three (3) contractors who were 30 days or more past due and he continues to work closely with them to ensure payment.

- 1) Peninsula Air Conditioning owes March and April 2013
- 2) Pro-Plumbing owes February, March and April 2013
- 3) Robert's Fire Stop owes March and April 2013.

#### Contractors referred for Collections:

Cal Pacific Plumbing - Mr. Swanson said \$43,000 was collected from the employer's bank 1) account based on the judgment. Both liquidated damages and principal are still due. A judgment was received which included legal fees.

South City Refrigeration & Air Conditioning. South City has been late, but the plan office 2)

confirmed that April hours were paid.

Relating to Dinelli Plumbing, it was reported that their delinquency was paid after the received correspondence from the Trust Counsel.

#### 6. . Report by Legal Counsel - Dick Grosboll

#### A. Status of IRS Application

Mr. Grosboll reported that the IRS had responded to the Favorable Determination Letter request (submitted in January 2010) and that he was providing an additional document to the IRS. He anticipates that the IRS approval will be issued soon.

#### B. Summary Plan Description

Mr. Grosboll reported that the revision to the Summary Plan Description is in progress. He said he would provide the Administrator and the Consultant with draft copies for review. This will be added to the next agenda for discussion, although the document will likely not be ready for approval until later in 2013.

#### Investment Consultant Report, New Century Partners - Steven Callow 7.

Mr. Callow distributed portfolio appraisals as of December 31, 2012 and May 31, 2013.

The total market value of the portfolio as of May 31, 2013 was \$47,490,503, with \$29,423,056 in Mutual Funds, \$18,066,626 in Unit Trusts and \$821 in Cash & Equivalents. Mr. Callow reviewed the investments in detail and responded to Trustee questions.

#### 8. Assets and Expenses

#### A. Financial Statements

After a review and discussion, it was **M/S/C** to accept the financial statements for the months of January, February and March 2013 as presented.

#### B. Payment of Bills

The Trustees reviewed the itemized checks. It was **M/S/C** to accept Checks #3578 to 3578 to 3603 for the payment of bills as presented.

#### 9. Actuary/Consultant Report, Kaufmann & Goble - Sid Kaufmann and Marci Vukson

#### A. Participant Activity Report

Ms. Vukson distributed the U.A. Local Union 467 Defined Contribution Plan Participant Activity Report dated June 11, 2013 and reviewed Section 1 pages 7 and 11 regarding Investment Options and the high balance in the fund. She also reviewed Section 2 regarding the Contribution Rate History, Contributions vs. the Prior Year, a distribution history on page 23. She also reviewed the fund changes made during the first quarter of 2013 shown on pages 26 and 27. On page 38, Ms. Vukson reviewed mutual fund payments versus fees paid.

After discussion and questions, it was **M/S/C** to accept the Participant Activity Report for the Defined Contribution Plan as presented. The Trustees complimented Ms. Vukson on the report. The report is on file with the Administrative Office.

#### 11. Report by Financial Auditor - Alex Miller

Mr. Miller reviewed a copy of the financial audit for the years ending December 31, 2012 and 2011. He said it was a clean, unqualified opinion. It was **M/S/C** to approve the financial audit as presented and to timely file all necessary tax forms, including filing the Form 5500 electronically.
