5. <u>Delinquency Report – Mike Swanson</u>

Chairman Swanson distributed the Delinquency Report dated September 18, 2014. The report indicates there are several contractors delinquent for the July 2014 fringe benefits payment due by August 20, 2014.

The report lists five contractors 30 days or more past due, with whom he continues to work closely to ensure payment:

6. Report by Legal Counsel - Dick Grosboll

A. <u>Update on Restated Summary Plan Description</u>

Mr. Grosboll provided the Trustees with the restated Summary Plan Description for their input. In particular, he asked for input from the Union Trustees given their familiarity with issues raised by members. The goal is to finalize the SPD prior to the next Trust meeting for distribution to the Participants. Mr. Saunders indicated that he would provide his comments within the next couple of weeks.

B. <u>Status of Pending Matters/Legal Update</u>

Mr. Grosboll provided a summary of the issues related to the conversion of the Plan to a 401k Plan for use in the notice being distributed to Participants and/or a Union newsletter/notice.

C. <u>Status of Collection Matters</u>.

Legal counsel indicated that Ben Lunch in his office had obtained a Default Judgment against Peninsula Air and that a Motion for Default Judgment had been filed. He anticipates receiving that Judgment soon. A Demand letter was sent to A. Bryant Plumbing. If no payment is made and/or no response to the letter is received, legal counsel indicated it may be necessary to file a lawsuit. The Trustees concurred. A Judgment was obtained against South City. Efforts to collect have been unsuccessful to date. Legal counsel reported that South City has no current work in UA 467's jurisdiction.

7. Investment Consultant Report, New Century Partners - Steven Callow

Mr. Callow distributed portfolio appraisals as of August 30, 2014. The total market value of the portfolio as of August 30, 2014 was \$54,650,278, with \$33,753,865 in Mutual Funds, \$20,895,573 in Unit Trusts, and \$840 in Cash & Equivalents. Mr. Callow indicated that the yields on the Plan assets had been positive during 2014. The yields continue to exceed the benchmarks in most situations.

8. Actuary/Consultant Report, Kaufmann & Goble - Sid Kaufmann and Marci Vukson

A. Participant Activity Report

Ms. Vukson distributed the Participant Activity Report dated September 18, 2014. After review, it was **M/S/C** to accept the Participant Activity Report for the Defined Contribution Plan as presented. The report is on file with the Administrative Office.

9. Administrator Report, UAS - Judy Sargent

A. <u>Distribution Report and New Loans</u>

Following review of the list of Monthly Installments, New Installments, Partial Lump Sum Distributions, Lump Sum Distributions, Lump Sum Additional Interest and New Loan Reports, it was **M/S/C** to approve the reports as presented. The reports are attached to these Minutes.

B. Annual Notice Regarding Expenses of the Plan

Ms. Sargent referenced the Annual Notice Regarding Expenses of the Plan, dated June 2014. The notice was timely distributed to the Plan participants.
